Sub.: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Allotment of 5,00,000 equity shares pursuant to exercise of warrants allotted on preferential basis

Consequent to above mentioned allotment, the issued, subscribed and paid-up equity share capital of the Company stands increased to Rupees 22,02,20,800 divided into 2,20,22,080 equity shares of face value Rupees 10.00 each from Rupees 21,52,20,800 divided into 2,15,22,080 equity shares of face value Rupees 10.00 each.
